

Our book project is now established at Port Augusta prison and we have very much appreciated the support of the activities team and the education staff at the prison.



We also met some of the programs team at the prison to talk about Magnolia and trauma-informed criminal justice. Everyone was very enthusiastic about what we are doing!



# OUR PRACTICE GUIDE PROJECT

The Magnolia Project is committed to supporting the development of trauma-informed and compassionate criminal justice practice in any way that we can. An important part of this is strengthening the cultural safety of the criminal justice system.

Over the last few months we have been working with the Aboriginal Legal Rights Movement (SA) to develop resources to support mental health professionals who appear as expert witnesses in pre-sentencing matters.

Together we have develop a new practice guide that provides mental health professionals with key information about the different ways in which the social and emotional wellbeing of First Nations defendants is relevant to legal decision-making.

Our Guide is currently out for stakeholder feedback, but we hope to be able to finalise this and publish it on our website in a few months time. Watch this space and please get in touch if you want to find out more!

#### SOME NEXT STEPS

We are continuing our academic work on trauma-informed practice.

Katherine has a book contract to present her research findings about trauma-informed sentencing in the Adelaide courts, and has recently written a paper explaining why raising the age of minimum criminal responsibility is important from a trauma-informed perspective.

Andy's work with Catia and youth justice continues to lay a foundation for the development of trauma-informed practice with young justice involved people. We have written articles on co-production (with Katherine, Luke and Jo ), on trauma-informed leadership (with Luke and Mellanie), and on measuring the outcomes of a trauma-informed youth justice service (with Luke, Lyn, and Katherine H.). We have others in the pipeline on topics such as the importance of legislation, on how understanding the profile of young children in the justice system is important to raising the age, and on the evidence base to support the implementation of trauma-informed youth justice.
